ANNUAL MEETING:

On Wednesday, November 15th, we will be presenting the final proposal of changes for the Bylaws of the Lowell Chamber of Commerce. Below you will see some of the changes that will be presented. Please watch your email for the remaining changes prior to the annual meeting. We will also be voting for members of the board of directors. If you are interested in being on the ballot for the board of directors reach out to Chrissie Moore at 219-628-5258 or Nancy Frigo at 219-746-4334 or email hello@lowellinchamber.co before Thursday, November 9th. If you would like a copy of the current bylaws prior to the meeting please email hello@lowellinchamber.co.

The government of the Chamber and the direction of its works shall be vested in a Board of Directors consisting of eight (8) Members in Good Standing along with two (2) permanent positions of a representative from the School Corporation & the Town Manager/Administrator (or designated representative). At the next scheduled Board meeting following the annual election, the returning, the newly elected, and the outgoing Directors shall meet to nominate and elect four (4) officers, who shall be: President, Vice-President, Recording Secretary and Treasurer, who are to serve for the ensuing year. The President and the Vice-President shall be elected from the members of the Board of Directors. The Recording Secretary and the Treasurer may be elected from the members of the board of Directors, or from the Membership.

Desirable attributes of all Board of Director Members

- Good organizational skills
 - Honest/trustworthy

Good communication skills and be able to keep confidential matters confidential.

Role of the President

The President shall preside at all general meetings of the Chamber and the Board of Directors. The President is charged with providing leadership and direction to the BOD and Committees. The President is responsible for ensuring that the BOD & Committees fulfils its responsibilities for governance and success. The President is generally the spokesperson and should work to maintain key relationships within and outside the Chamber & its committees and performs all duties incident to the office. The president shall appoint all committees, subject to the Confirmation of the Board of Directors and they shall act as an ex-officio member. Assist in the development of partnerships with other boards and organizations that are relevant to the goals of the committee.

Role of Vice-President

The Vice-President, a member of the Board, shall temporarily act in the absence of the President. Vice-President shall work with the President to coordinate the overseeing of the Committees and Chamber of Commerce duties.

Role of Secretary

The Secretary shall record, dictate, distribute, and read, provide the minutes of all Board of Directors' monthly meetings, and other such related functions as determined by the Board. Manage the general correspondence of the committees except for such correspondence assigned to others. Secretary shall be on the membership & welcoming committee, additionally shall work with the social media and communications/events committee to coordinate marketing.

Role of the Treasurer

The Treasurer shall receive and disburse the funds of the Chamber. All disbursements shall be made by checks which shall be signed by any two (2) of the Board of Directors. All disbursements for normal operating expenses of the chamber not exceeding Five Hundred Dollars (\$500.00) shall be paid in a timely manner with the Board of Directors ratifying these payments at the first Board meeting following such disbursements. All other disbursements in

excess of Five-Hundred Dollars (\$500.00) must be approved by the Board prior to payment. The Treasurer shall make monthly reports to the board of Directors, which may at its discretion, require the Treasurer to give acceptable bond, in such sum as the Board may determine for the faithful performance of his or her duties. All momentary deposits given to the chamber require that a receipt of deposit be given to the Treasurer within 5 business days after the deposit is made. The Treasurer must compile a monthly financial report to be distributed at the Monthly Board of Director's meeting. At the year's end General Membership meeting the Treasurer must provide/present year's end report with general profit and loss analysis.

2023 Holiday Magic Christmas Trees

It is hard to believe but winter is around the corner. The Lowell Chamber of Commerce is pleased to announce it is time for our 8th annual Holiday Magic Christmas Trees

And to accommodate our Christmas lovers, the Lowell Chamber of Commerce has started planning for this beautiful event. The staked trees will be located at

Olde Towne Square at the corner Commercial Ave. and Fremont St.

Orders for the Christmas trees are being taken now. The trees are purchased from Leo's Pet Garden & Home, the average height will be between 4-6ft and they will be Fraser Firs.

The cost of the trees will be \$75.00 for Chamber members. For non-chamber members the cost will be \$85.00. When a tree is purchased, the Chamber agrees to provide electricity to the tree, an extension cord and a sign indicating who the sponsor is or who the tree is dedicated to.

All trees must be paid for when they are ordered. Only payment guarantees you will have a tree. A receipt will be given as proof of purchase.

To make the project run smoothly, the committee has set a few simple rules that **must** be followed:

- Because of wind and liability concerns, the trees should be decorated with lights and decorations that are carefully wired or tied to the tree branches.
- No decorations or spotlights of any kind will be allowed on the ground next to the tree .
- The sign placed next to the tree must not be decorated.
- It is important to have enough lights on the tree to make it stand out at night,

LED lights are highly RECOMMENDED

• The trees must be decorated by December 1st for the Winterfest scheduled for Dec 2nd.

• If a sign is damaged or removed from the tree, a new sign is ordered at the cost of the sponsor.

We expect the trees to be stacked by Nov. 18th. Sponsors will receive a call from the chamber once the trees are set. <u>Sponsors must remove decorations from trees by January 5, 2024.</u>

We will be having a decorating contest, so please watch for more details to come on how to submit your votes!
